A LETTER FROM THE CHAIRMAN OF THE BOARD

It is truly my privilege to serve as the Chair of Philabundance. It is a joy to work with such a dedicated team and such a thoughtful Board to provide help, compassion and dignity to people in need throughout the Delaware Valley.

Philabundance had a terrific year in 2019. You'll see dozens of important initiatives in this annual report, but there were some transformative high points. We secured funding for, and started construction on, a new home for our workforce development program, Philabundance Community Kitchen; we launched several innovative, interdisciplinary pilot programs designed not merely to address food insecurity, but to begin to eliminate it in our communities; and we expanded our distribution of healthy foods to Philadelphia, its surrounding counties and southern New Jersey, ending

the year with a record-breaking WMMR Preston & Steve Camp Out for Hunger event that by itself yielded over 1.8 million pounds of food for our hungry neighbors.

As of this writing in 2020, we know the world is a different place, and that the consequences of the COVID-19 pandemic make Philabundance more important than ever. Our organization will continue to rise up against poverty and dedicate ourselves to ensuring that every person in our communities gets the food they need to thrive.

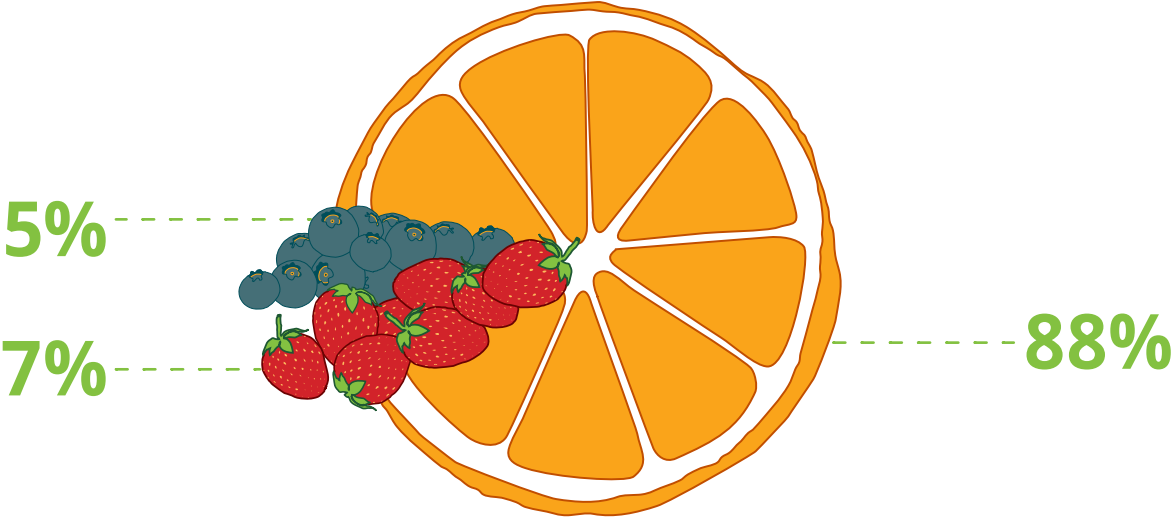

COMMUNITY EMPOWERMENT

Philabundance partners with over 350 member agencies to distribute food to our neighbors in need.

Notable accomplishments in 2019 included:

- The Backpack program more than doubled from 10 to 27 sites, distributing 60,000 backpack kits offering free, nutritious and easy-to-prepare meals and snacks for kids facing hunger.
- Philabundance was awarded a contract from the State Food Purchase Program (SFPP) for Philadelphia County for the first time! SFPP provides grants to purchase and distribute food to individuals with low-to-no income, meaning more food and less paperwork so we can spend more time feeding those in need.
- The Emergency Food Assistance Program (TEFAP), a federal program that helps supplement the diets of low-income Americans by providing free emergency food assistance, now distributes through Philabundance, leading to an additional 760,000 pounds of food for our neighbors.

Philabundance hosted the first annual Hunger Heroes Agency Appreciation event to celebrate the work of our member agencies. Generously sponsored by our partner, Aetna, ten awards were presented to agency members who provided exemplary service in the community.



VOLUNTEERS

Philabundance benefited from the amazing support of 15,000 volunteers in 2019 who dedicated over 25,000 hours to fighting hunger by sorting 970,000 pounds of food. We would not be able to do this work without them!

Our volunteers also dedicated time to:

- Weekly produce distributions at our agency partners
- Gleaning produce at the Philadelphia Wholesale Produce Market
- Packing emergency hunger relief boxes during the government shutdown
- Processing food donations from significant new donors, including Starbucks and Amazon



EMERGENCY MARKET – FOOD FOR THE FURLOUGHED

In December 2018, the federal government experienced its longest shut down in history. Over 40,000 federal workers in our area were not paid for over a month as a result of the shutdown.

Philabundance worked with local partners to do what it does best—bring food to people who need it. To address the needs of federal workers, Philabundance held three emergency markets offering a wide variety of food, and we were supported with additional funds from generous donors.

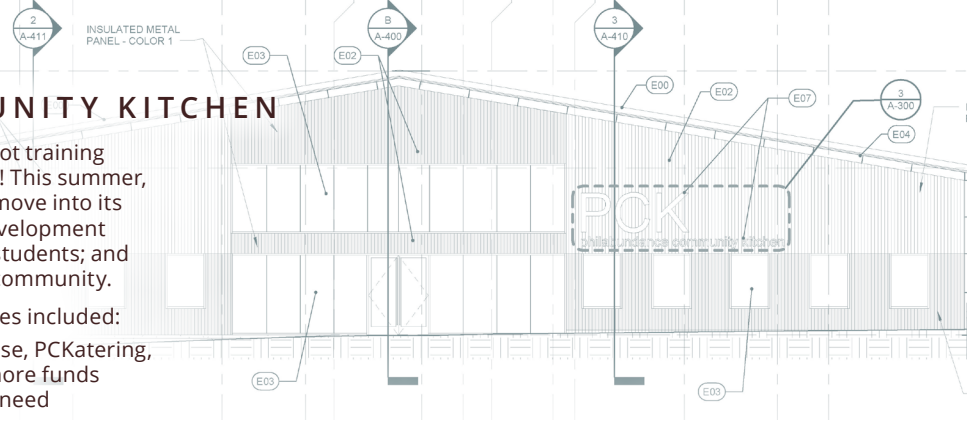


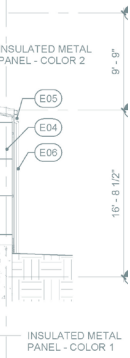
PHILABUNDANCE COMMUNITY KITCHEN

Breaking ground on our new 18,000-square-foot training facility was an exciting and long-awaited event! This summer, Philabundance Community Kitchen (PCK) will move into its new home, allowing the culinary workforce development program to extend its curriculum; enroll more students; and provide up to 20 times as many meals for the community.

Additionally, PCK's milestones and opportunities included:

- The tremendous growth of our social enterprise, PCKatering, which hired more students and is providing more funds to support the program and our neighbors in need
- PCK's renewed contract with the City of Philadelphia at Suburban Station's Hub of Hope, which offers meals and services to people facing homelessness
- PCK's partnership with Federation Housing, which provides 23,000 additional meals to the community annually





ABUNDANTLY GOOD

Last year, Philabundance received a Dairy Innovation Grant through the PA Department of Agriculture to market our retail brand, Abundantly Good™, Philabundance's product line that benefits people, planet and profit. For every product sold, proceeds go back to Philabundance to provide high-quality items for those in need.

The grant allowed us to promote our brand more widely, and as a result, our local farm partners made over \$56,000, and Philabundance provided \$10,400 worth of free cheese to our neighbors in need.



SAFETY IS AT OUR CORE

Our Berks warehouse received a near-perfect score of 990 out of 1000 from the AIB International Food Manufacturing Practices Inspection, which demonstrates our dedication to providing safe, high-quality food products and shows that we exceed food safety regulations!

STAR-STUDED PHILABUNDANCE

In June, we secured national press coverage on Good Morning America by partnering with the Mayor's Office of Education to spotlight Charles Reyes, a Community Schools staff member who runs a healthy food distribution program in North Philadelphia. And in September, we were grateful to have professional athletes join the fight against hunger by participating in a public service announcement that provided increased visibility and awareness of hunger in our area.



ENDING HUNGER. FOR GOOD.

As part of our strategic plan last year, Philabundance launched the Ending Hunger. For Good. (EHFG) initiative. EHFG focuses on building collaborations with other organizations to pair healthy food with critical services to find and implement long-term solutions to food insecurity.

Our first collaboration, with Habitat for Humanity of Montgomery and Delaware Counties and the Pottstown Cluster of Religious Communities, combined food resources, case management and financial coaching to move families toward long-term stability. All growth was measured by the University of Pennsylvania's ImpactED through a grant from the Pew Charitable Trusts' Evaluation and Capacity Building Initiative.

SUSTAINABILITY PARTNERSHIP

Marketplace PHL and the Philadelphia International collaborated to rescue food from over 65 merchants at the airport as a first step to developing a sustainability roadmap for the future. To date we have rescued 21,883 pounds of food from vendors such as Chickie's & Pete's, La Colombe and Hudson News.

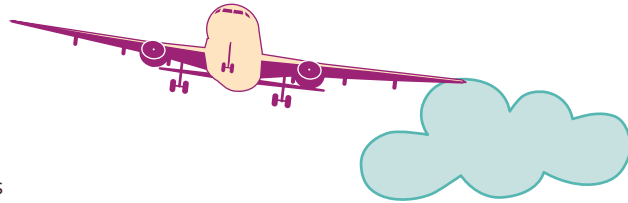
FOOD RESCUE

Forty percent of all food in the US is wasted annually due to manufacturing guidelines and the disposal of surplus food. We step in before these nutritious and perfectly safe food products go to waste. Through participation in our Retail Rescue program, more than 340 food donors provided 11.6 million pounds of food that went to people—not landfills—in 2019.

We also collaborated with Delaware Valley Community Health and Vetri Community Partners to implement a weekly food distribution with a bi-weekly class and a family meal for those with high levels of chronic illness, including obesity-related conditions; significant barriers to adequate health care; and a lack of access to culturally and language-appropriate services. The pilot is funded by the Philadelphia Collaborative for Health Equity (PCHE).
